### NOTIFICATION

The decisions taken in the 3<sup>rd</sup> meeting of Empowered Advertisement Committee held on 25/05/2022 constituted vide notification No.F.65 (10)-ICA/ADVT/2021 dated 24<sup>th</sup> May, 2022 in compliance of implementation of Advertisement Policy, 2021 is given below.

1. **Fixation of eligibility criteria after Covid Pandemic:** As per notification No.65(10)-ICA/Advt./2021, dated 7<sup>th</sup> October,2021 on recommendation by the Empowered Advertisement Committee, the eligibility criteria for categorization of different Print media was relaxed. Now, after the covid pandemic situation, the minimum eligibility criteria is further modified as-

2. **Modification of eligibility Criteria for categorization of Electronic Media:** For wide coverage of government advertisements the criteria for categorization of Electronic Media as notified via No. F.65(1)-ICA/ADVT/2021,dated 19<sup>th</sup> June,2021 may be modified in the following way-

**NB:** For Website & TV. Channel bill must be submitted with display schedule of the advertisement in a compact disk (as telecasting & displaying proof).

**3. Distribution of Advertisement:** For smooth distribution of Advertisement in different categories of media ratio of release of Advertisement may be as follows-

**A. Print Media:** Each advertisement for print media will be distributed in 6(six) newspapers and in the following ratio-

**NB:** The Department shall have the discretionary right to release any single advertisement to different media like Print Media, Electronic Media & Web-media depending upon the gravity of advertisements as well rotation basis.

4. **Billing procedure for websites:** All the websites must submit Screenshots (depicting uploading date, time & impressions) of the advertisement along with its triplicate bills. Also, the categorized websites must submit monthly declaration by 3<sup>rd</sup> day of every month detailing advertisement code, uploading date & time.
5. **Submission of Telecasting Schedule of issued advertisement:** All the Electronic Channels must submit (via mail at ICA) telecasting schedule of the advertisement by the next day of released advertisement. The authenticated schedules also need to be submitted along with the bill copies of the respective advertisement.
6. **Fixation of percentage of advertisement between Print, Electronic channel, Web media etc out of total advertisement:** As far as practicable the ratio of annual release of advertisement as recommended in first meeting of Empowered Advertisement Committee may be further modified as-

7. **Release of advertisements in outside media:**

As and when required govt. advertisements will be released in outside media with approval of the competent authority.

Also, as per Clause 4A(X) of Tripura Advertisement Policy, 2021, "The advertisements in outside states newspaper will be released as per GFR norms as notified by the State government." Accordingly, advertisement will be released in the nationally reputed outside states newspaper. A list of such newspaper is given under-
