Contradiction

Requisitions was placed to the Teachers' Recruitment Board, Tripura for selection as well as recommendation of candidates for the following posts vide this Directorate letter No.F.1(1-50)/SE(NG)/2019 dated 2.3.2019.

- 1) Post Graduate Teacher :- 75
- 2) Graduate Teacher :- 625

Accordingly, Teachers Recruitment Board, Tripura conducted selection test (STPGT) and (STGT) on 13.6.2019 and thereafter recommended names of selected candidates to this Directorate vide their letter No.F.2(1-18)/GEN(TRBT)/REC/2019/165 dated 11.9.2019.

- 1) Post Graduate Teacher :- 10
- 2) Graduate Teacher :- 450

The Teachers' Recruitment Board, Tripura has recommended names of following 2(two) candidates to both the posts of Post Graduate Teacher and Graduate Teacher.

- 1) Sri Bastab Debbarma (ST)
S/O. Late Akshoy Debbarma,
Vill. & P.O. – Belchara, Khowai.
- 2) Sri Shibu Das (SC),
S/O. Hari Mohan Das,
Vill. & P.O. -North Brajapur Panchayet, Bishalgarh.

On receipt of the above recommendations from the Teachers' Recruitment Board, Tripura, the Directorate of Secondary Education has issued offer of appointment in respect of the above persons on 4.11.2019 in both the posts of Post Graduate Teacher and Graduate Teacher. They have accordingly accepted the offers of appointment of Post Graduate Teacher within the scheduled date on 28.11.2019. They did not accept the offers of appointment of Graduate Teacher and surrendered its in writing.

It is stated here that a candidate may apply for more than one post if he/she has the requisite eligibility. As such, the above persons applied as well as appeared in selection tests for both the posts of Post Graduate Teacher and Graduate Teacher. Accordingly, they were selected for both the posts, but have accepted offer of appointment only in one post i.e. Post Graduate Teacher.

In the recent list of Under Graduate Teacher(I-V) and Graduate Teacher(VI-VIII) recommended by TRBT on 2.12.2019 to the Directorate of Elementary Education, it is found that a total of 94 candidates have earlier been recommended for Graduate Teacher(IX-X). Also 94 candidates have been recommended for both Under Graduate Teacher and Graduate Teacher(VI-VIII). So as per normal practice these qualified candidates will get 2 offers of appointment. But while joining into service they have to forgo/surrender one offer of appointment.

So, the Education Department contradict the news “শিক্ষক নিয়োগে একই ঘটনার পুনরাবৃত্তি ঘিরে ব্যাপক ক্ষোভ” as published in the ‘Dainik Sambad’ on 10.12.2019.
