







- 3. Nirmahal Organic Farmers Producer Company Ltd in Sepahijala comprising Bishalgarh, Jampuijala, Mohanbhog, Boxanagar, Kathalia agri sub divisions. They have exported 502 kg queen pineapple to Hyderabad, 234 kg queen pineapple to Delhi in May 2021 and exported don225 kg queen pineapple to Gauhati, locally marketed 200 kg queen pineapple in June at Rs. 20 per piece, locally marketed 300 pieces and exported 400 pieces of Gandaraj lemon to Gauhati at Rs. 2.50 per piece, exported 10 local jackfruits to Gauhati at Rs. 22 per piece, exported 474 kg of queen pineapple to Bangalore and 250 kg to Hyderabad at Rs. 20 per piece, exported 10 pieces of Gandaraj lemon at Rs. 2.50 and 10 local jackfruits at Rs. 22 per piece to Hyderabad, exported 87 kg queen pineapple to Delhi at Rs 19 per piece in June 2021, locally marketed 590 kg Kew pineapple at Rs. 20 per piece this July. All these were executed through ICCOA.
- 4. Kalajhari Organic Farmers Producer Company Ltd in Gomati district including Matabari, Amarpur, Ompi, Karbook agri-subdivisions. They have exported 25 kg organic scented rice (Kalikhasa) at Rs. 90 per kg and 18.5 kg organic honey at Rs. 650 per kg to Hyderabad through ICCOA in June 2021. They have also exported and locally marketed some amount of queen pineapples to Delhi in June.
- 5. Muhuri Organic Farmers Producer Company Ltd in South district comprising Bagafa, Satchand, Rupaichari agri-subdivisions.
- 6. Unakoti Organic Producer Company Ltd in Unakoti district comprising Kumarghat, Gournagar agri-subdivisions. They have exported 600 kg in first consignment and 1000 kg Kew Pineapple in second consignment through SIMFED to Kolkata and have locally marketed 1000 kg Kew Pineapple at Rs. 20 per piece this July.
- 7. Hataini Organic Farmers Producer Company Ltd in North district comprising Kadamtala, Panisagar, Kanchanpur, Damcherra agrisubdivisions.
- 8. Dhalai Organic Farmers Producer Company Ltd in Dhalai district comprising Chawmanu, Selama, Durga chowmuni, Ambassa and Gandacherra agri- subdivisions.

Assistant Director also shared that certification process is not that easy as the process is followed by registration under APEDA (Agricultural and Processed Food Products Export Development Authority), internal audit by APEDA. The service provider looks after the registration of farmers, training, documentation, Internal Control System (ICS), management, facilitation, marketing, formation of FPCs etc. "After completion of 3 years, if everything is fine after audit, the organic certification is given by a certification agency," he added. During Phase I, the certifying agency was 'Onecert International' and during Phase II, SGS was the certifying agency. SIMFED was the only service
