Terms & Conditions /Guidelines

1. Filled Application form with necessary supporting documents may be physically submitted to the Directorate of ICA, Gandhighat (or mailed to "tfti.icatripura@gmail.com") during the office hours of weekdays only, from the date of publication of Admission Notice till the last date of submission.
2. Initially preference will be given to the candidates of Tripura.
3. The last date of submission of filled in application is **20th October 2022**. No application will be entertained beyond the last date.
4. Age limit for aspirants is 18 – 35 years.
5. Minimum qualifying percentage of marks in Madhyamik/10(+2) will be 45 % in case of SC/ST/PH aspirants and 50 % for Others.
6. An applicant is allowed to opt for only one course.
7. The Application Form should be neatly filled up in legible handwriting.
8. The decision of the Scrutiny Committee will be final.
9. Any attempt at canvassing/influencing/bribing the Scrutiny Committee in any form would lead to permanent disqualification of candidature.
10. Admission process will be deemed to have been completed only after payment of requisite fees (registration & course fee).
11. No refund of admission/course fees will be allowed after classes start and somebody opts out of a course.
12. Regular attendance in class is mandatory including special classes on weekends/holidays.
13. Any misdemeanour in class may lead to expulsion from the course and forfeiture of the admission fees.
14. No residential facility is available.
15. A candidate selected for admission will be required to sign an undertaking to abide by the Rules & Regulations of the Institute and upheld its dignity and repute.
