The eligibility criteria for providing of employment to family members of Families of person killed in political violence were as follows:

- a) Employment will be provided to 1 (one) of the family of the victim.
- b) Employment will be provided subject to eligibility as per recruitment rules.
- c) There should be no other earning member in the family.
- d) Employment will be provided subject to confirmation that the incident was one of political violence from the district Superintendent of Police concerned.

This shall take immediate effect.
