Drinking water connection to 45,258 households in Sepahijala under JJM

Virtual Court launched for easy disposal of petty traffic offences

With a view to dealing with the traffic offences in a better way Virtual Court Web Portal has been launched today in the state. The Chief Justice of Tripura High Court Indrajit Mohanti officially launched the portal for e-Challan from the auditorium of Tripura High Court today. The Virtual Court Web Portal has been developed by the e-Committee of the Supreme Court of India. This project has been launched on a pilot basis in the jurisdiction of SP, West Tripura to facilitate online payment of fines arising out of traffic violations. The High Court of Tripura has designated the Court of the

Judicial Magistrate First Class, Court No.1, Agartala, West Tripura as the 'Virtual Court', informed by the Tripura High Court in a press release today.

The press release informs, Virtual Court is a concept aimed at eliminating the presence of litigant and lawyer in the court and for adjudication of cases on a virtual platform. The concept has been evolved to efficiently utilise court resources and to provide the litigants with an effective avenue to settle petty disputes. Virtual court is administered by a judge over a virtual electronic platform whose jurisdiction may extend to the entire State and function 24X7.

The digital challans generated through the eChallan application will be sent in digital form to the designated Virtual Court and all the challans for the given day will reflect in the dashboard of the Virtual Court Judge. The Court, as per Section 208 of the Motor Vehicles Act, 1988 will issue summons to the traffic violator via SMS notification which will contain a web link to redirect the violator to the Virtual Court Web portal whereon the violator could make payment through Debit/ Credit card, Internet banking, eWallet, UPI

etc. or may opt to contest the challan as per law. The fine amount will be deposited in the e-Treasury through the eGRAS portal of the finance department. On this the violator will receive an acknowledgement indicting that the case registered is disposed. Citizens can access the portal on https://vcourts.gov.in/virtualcourt/.

The Virtual Court launching programme was also attended by the registrar general Datamohan Jamatia, judge of Tripura High Court Arindam Lodh, justice T. Amarnath Gour, justice S.G. Chattopadhyay, advocate general Siddhartha Shankar De, DGP V S Yadav, principal secretary L. Darlong, director of ICA Ratan Biswas and other top officials.

LPG connection to 11,287 households in Sabroom under PMUY

So far, free LPG connections have been provided to 11 thousand 287 households in Sabroom sub-division under Pradhan Mantri Ujjwala Yojana. The gas connections have been provided through three gas agencies of the sub-division. This was informed by Sabroom Sub-Divisional Magistrate's office.

Agricultural machines distributed at subsidy in Boxanagar agri-sub-division

Power Tillers, spray machines, thresher machines, pump sets and weeder machines have been provided to 571 farmers of Boxanagar agriculture subdivision under Sub-Mission on Agricultural Mechanization scheme at subsidised rates. 45 lakh rupees was spent for this.

19 Deep tube wells in Charilam under JJM

19 deep tube wells have been installed in Charilam block under Jal Jeevan Mission in the previous financial year. Apart from that, a submersible deep tube well has been installed. Free drinking water connection has been provided to 3 thousand 656 families of the block from these drinking water sources under Jal Jeevan Mission. To ensure 100%

availability of drinking water in every household in the block, more 42 deep tube wells and 82 submersible deep tube wells will be installed under Jal Jeevan Mission. This was informed by Drinking Water & Sanitation department.

38,921 Mandays generated in Rubri Twisa Village under MGNREGA

38 thousand 921 mandays have been generated in Rubri Twisa Village of Hezamara block under MGNREGA in the previous financial year. Different development works were implemented in the village such as construction of new road and repairing of old roads, water body excavation and repairing, land levelling and creation of irrigation sources etc. 73 lakh 88 thousand 373 rupees has been spent for this.
