Equipments distributed under biovillage project

Under the initiative of bio-technology department various equipments were distributed recently among the selected beneficiaries of bio-village project in camp mode in Krishna Sangha bio-village under South Charilam Gram Panchayat of Charilam block. In the camp 60 kg bioferitilizer and 10 kg. bio-fungicide were given to each of 27 beneficiaries. An amount of Rs. 61,000 has been spent for this. Minority students to be awarded by minority welfare department

Students belonging to Muslim, Buddhist (non-tribal), Christian (non-tribal), Shikh, Jain communities who have secured at least 60 per cent marks in the Madhyamik and

Higher Secondary examinations from any recognised school, Madrassa, Madrassa Alim, Madrassa Fazil will be awarded Maulana Abul Kalam Memorial Award. Moreover, one topper Muslim girl student in Madhyamik and one topper Muslim girl student in Higher Secondary examination will be awarded with Begum Rokeya Gold Medal.

Moreover this year minority girl students who have secured a rank in the top ten list of the TBSE, ICSE and CBSE board examinations will be given Chief Minister's Gold Medal. It will carry a cash prize of Rs. 19,000 and a gold medal worth RS. 6000. Eligible candidates have been asked to apply to the concerned directorate along with their name, father's/ guardian's name, address, ration number, name of schools, card subdivision, name of the examination obtained, passed, marks AADHAAR number, bank account details, mobile number etc by September 15. Santosh Das, director of the minority welfare department has informed this.

Assistance under SEDP scheme in Jampuijala

Nine ex-militants are getting assistance from the tribal welfare department under Special Economic Development Package (SEDP) scheme in the present financial year in Jampuijala agriculture sector with the initiative of Jampuijala sub division agriculture supervisor. However, the amount will be given in two installments. Each beneficiary will be given 44 thousand 895 rupees in their bank accounts in their first installment.
