Prepaid auto rickshaw and taxi service had been launched at MBB Airport yesterday. As per primary prepaid chart, prepaid service is available for travelling to Agartala city and to 73 different suburban areas. Santosh Saha, Chairman of TTDCL participating in the discussion, said that idea of setting up a Tea Auction centre is being considered for the purpose of marketing the tea produced in the state in the foreign market. A logo has already been created to popularize Tripura Tea. Tea produced in the state is branded as Tripureshwari. In order to make tea available in the state, the state Government is making it available to the public at low cost through public distribution system. He said that Prime Minister Narendra Modi announced Act East policy to prioritise development of North East region. As a result, Rail and

Air connectivity has been established with other states and different regions of the country. He said that it is very necessary to have a tea auction centre in Tripura. I want cooperation of Tea Board of India for this. If the tea auction centre is established in the state the tea producers of the state will get benefit as well as the

economic base of the state will be strengthened.

Speaking as a special guest Abhishek Chandra, the special secretary of the Department of Industry and commerce said that there are Tea auction markets in Kolkata and Guwahati. To benefit the producers, sellers and buyers establishment of tea auction centre is required in the state. Additional director of Industry and Commerce Subhas Chandra Das, Managing Director of TTDCL Maniklal Das and Executive Director of Tea Board of India Arunita Phukan Yadav participated in the discussion. Deputy director of Tea Board of India Kamal Chandra Vaishya delivered welcome address.

The family of Tushar Saha said that treatment of Tushar Saha was not possible without the assistance under PMJAY scheme.

Secretary of health department, Government of Tripura, Dr. Debasish Basu and Chief Executive Officer of PMJAY Dr. Shubhendu Debbarma were present on the occasion at NIC conference hall of Secretariat. Almost 14 lakh beneficiaries of the state are covered under PMJAY scheme. More than 1.65 lakh people of the state have availed medical service till now.
