Terms & Conditions:

- 1. The local Firms/Agencies with reputation to promote the state will be given preferences, so that local skills can be developed.
- 2. Defective or incomplete applications of Expression of Interest for empanelment in any respect shall not be considered.
- 3. Earnest money will have to deposit at the shape of demand draft on any nationalized bank. A Rs.5,000/-(five thousand)only for each application have to be deposited at the time of submission of quotation in favor of Director, Information and Cultural Affairs, Government of Tripura. Earnest money will be released to all unsuccessful bidders after arriving a decision on the matter.
- 4. Lowest 5 bidders will be selected for empanelment but in-case the requisite criteria are not met than House/Houses with all the matching criteria shall be selected and in that case the lowest bidder may be less than 5 or as per availability.
- 5. The bidder shall have a Registered Production House.
- 6. The bidder shall have own Production House with Recording & Editing Studio facility.
- 7. Application has to submit a synopsis describing previous experience and capability for doing the works in about 300 words.
- 8. Necessary contents will be supplied by the various State Government Department to selected agencies who will prepare short Advertisement film, Jingles, Documentary and Video recording etc.
- 9. For making a "Jingle" of 20 sec, 40 Sec and 60 Sec, the bidder should not bid more than Rs.5,000/-,Rs.8,000/- and Rs.10, 000/- respectively. Similarly, for "short ad films" of 30 Sec, 60 Sec and 90 Sec, the bidder should not bid more than Rs.10,000/-,13,000 /- and Rs.15,000/- respectively and for making "documentary films" of 2 minutes,5 minutes and 10 minutes the bidder should not bid more than Rs.20,000/-, Rs.25,000/- and Rs. 40,000/-.In case of preparation of short ad films exceeding 90 Sec, the amount for every extra sec will be calculated Rs.150/- and for documentary exceeding 10 minutes, the amount will be calculated as Rs.5,000/- for every extra minute. For making a "Video Recording and Editing" the same of 1 minute, the bidder should not bid more than Rs.2000/-. Similarly, the amount for every extra minute video recording and editing, will be calculated Rs.1500/-.
- 10. Screening Committee: The bids submitted directly to the Directorate shall be screened by a screening committee constituted by the Director, ICA comprising Officers from ICA department as well as other State/Central Government departments to be notified separately. The recommendation of the screening committee with financial rate as quoted against the selected bidders will be sent to the Government for approval.
- 11. Sales Tax, Professional Tax Clearance Certificates and copies of Trade License and PAN Card should be enclosed along with the bid.
