Scope of Work

- 1. Installation 1 (one) 20' X 10' HD LED Board at the Centre Point and 4 (four) Nos. 12X 8 HD LED Boards at identified locations along the procession route from Durgabari to Dashamighat via Tulshibati, Kaman Chowmuhani, Post Office Chowmuhani, Paradise Chowmuhani, etc.
- 2. Ensure live feed from the Live Streaming Team on these LED boards from the start of the event till its completion.
- 3. The successful Agency must construct necessary platforms for the LED Boards, take power connection following Govt norms and ensure power backup to the 5(five) LED Boards except the one installed at the Centre Point, for which Dept. will coordinate.
- 4. The, Agency must ensure uninterrupted display of live streaming feed and establish a temporary communication system between their control centre, all camera locations and themselves
- 5. The number of LED Boards may be increased taking into account of the necessity
- 6. The detailed LED board location plans can be discussed on-site with ICA Department officials.

Terms and Conditions:

- 1. Eligibility: The agency / firm must have prior experience in similar projects, particularly in live streaming and LED installation. Proof of similar projects executed for government departments/PSUs on at least 5 occasions in the last three years must be provided.
- II. Submission of Bids: Bids must be submitted in two sealed envelopes marked as "Technical Bid for LED Board Installation and Projecting Live Feed of Maayer Gomon 2025" and "Financial Bid for LED Board Installation and Projecting Live Feed of Maayer Gomon 2025"

- III. Opening of Bids: Bids will be opened at 4.30 PM of 19th September, 2025 (however in the event of change in such schedule for opening of tender date & time will be intimated in due manner)

- V. The Technical Bid must include detailed specifications for the LED boards, live feed system, proof of experience, and relevant credentials (eg, trade license, GST registration, PAN, etc.).
- VI. Financial Bid. Detailed cost breakdown including taxes per LED Board and the total cost to be quoted.
- VII. Only those meeting the technical requirements will be considered for financial bid evaluation. The lowest bidder among qualified bids will be selected.
