CM briefs the press about the new health scheme

The state government is going to introduce a new scheme called Ayushman Tripura. This new scheme will target to cover all the poor people who were left out in the Ayushman Bharat-2011, with health facilities. Making this announcement at the secretary yesterday the chief minister Biplab Kumar Deb said

that this new scheme would cost the government Rs. 9 crore, adding that a total of 3,57,000 people of 84 thousand poor families would benefit from the scheme.

Briefing the press the chief minister clarified about the rumour being spread about introduction of service fee in government hospitals saying that three categories are being introduced in regard to offering health services in government hospitals. Those who fall in Antyoday category will be given totally free service; earlier all category people had to pay certain service fees. Now only APL people will have to pay service fee. Charges of various tests have been reduced now. A new category by the name 'priority household' has been introduced. This category people will enjoy free services of 131 tests, out of 148 chargeable tests. Thirty-five per cent in average fee has been reduced.

Citing about health infrastructure the said, chief minister due to long outstanding accounts health infrastructure is being retarded. Those who have Ayushman Bharat card are entitled to health insurance. The remaining fund after adjustment of all health packages is spent in developing health infrastructure. If registration fee is

introduced in hospitals information about the patients would be available and it will at the same time curtail corruption. Transparency will be set in as to how many patients have taken food or how much money has been spent. The new system is yet to be operational; once the discrepancies are done away with and NHM facilities are clubbed, the new scheme will be introduced in practice.
